Do not send cash. **Send money order or cashier's check payable to Morris College**. The one-time payment of (\$100.00) deposit will give the student the right to reserve a room by annually completing the Housing Agreement Form. The deposit will be refunded upon the student's graduation or separation from the college. If the student returns to college after separation, the (\$100.00) deposit must be paid again. **The Housing Agreement Form should be returned by June 30th** for the regular academic year (fall and/or spring semesters) summer session included.
